I undertake to leave the territory of the Republic of Poland at the latest on the last day of my stay authorised by National visa.

I am aware that holding National visa constitutes only one of the conditions for entry into the territory of the Republic of Poland. Obtaining National visa does not mean the acquisition of right to compensation in case of refusal of leave to enter the territory of the Republic of Poland as a result of failing to meet condition for entry, as specified by Alien's Act. Conditions for entry shall be checked again when entering the territory of the Republic of Poland.

I am aware that the National visa may be revoked if I will no longer continue to meet conditions for granting such visa.
